

Dhanlaxmi Bank-Retail Internet Banking/Mobile Banking Limits

The Retail Internet Banking/Mobile Banking has been set with transaction and daily limits for its transactions very similar to the ATM cash limit where the daily ATM cash withdrawals ranges from 20000 to 200000 and would be assigned as per the request.

The Limits available for RIB and MB are annexed below.

The existing and the newly acquired customers would be defaulted to **Silver** segment limits. There are two more segments of limits available, **Platinum** and **Gold** which can be communicated to the customers so as customers can chose any one of them as per their requirement.

The Retail Internet Banking/Mobile Banking customers (inclusive of HNI and Sole proprietors) who wish to upgrade their limits can follow the prescribed process.

The process is;

Branches to take approval from Regional Head for the customer required limit

Inform the customer to download the modified Channel Request Form and RIB/MB Limit Enhancement Undertaking Cum Indemnity from our site. (www.dhanbank.com)

Request the customer to select the limits required. The available limits are annexed below.

Branches may get the signed CRF from the customer and place request for the same via DCAMS. In DCAMS, branches may select the option, **Modify Category** under the Retail Internet Banking/Mobile Banking and further select the customer requested limit type.

Forward the Regional head approval mail along with the SR number to iboperations@dhanbank.co.in

Please note the validity of this will be only for three months and on expiry the user will be enabled with the default limit by the system.
